


KPFBA needs continuity in member support



Lakshadweep Veterinarians Delegation Visits KPFBA

A 15-member delegation of veterinarians from Lakshadweep Union Territory led by Dr. K.K Akbar, Nodal Officer of Training & Trainer, Department of Animal Husbandry, Lakshadweep and Dr. Koya, Director – Department of Animal Husbandry, Lakshadweep, along with veterinary officers of various islands of Lakshadweep visited KPFBA office on 22 March 2022.

Dr. Sushanth Rai.B. and Mr. Inayath Ulla Khan walked them through the new office premises and gave a presentation about the upcoming facilities in the building.

Dr. Akbar took the opportunity to congratulate KPFBA on its initiative to start the training center and laboratory in the college campus by gifting a memento depicting Lakshadweep for the new office of KPFBA. He also mentioned that the training center and lab would be of use to the poultry sector in the region and Lakshadweep would send personnel for training / workshops as and when there was activity.

The delegation is on a visit to Bangalore to get training on various veterinary animal husbandary practices. Addressing the delegation, Dr. Sushanth Rai mentioned that Karnataka was a major supplier of Hatching eggs to the island. The upcoming training center and laboratory, he added, would be open to all as the KPFBA was keen on expanding knowledge, training etc.

Lakshadweep poultry status: At present all the 9 inhabited islands have Hatchery/poultry production centers, under the direct supervision and control of Directorate of Animal Husbandry, UTLA. However, the above production centers are not able to meet the daily requirement of Lakshadweep which has a population of nearly 65,000. Lakshadweep requires minimum 40,000 Nos. eggs/day and 35,000 kg meat/ week in the coming years considering the population growth, eco tourism promotion etc. Hence, the UT Administration decided to outsource operation of feed mixing unit/ hatcheries/ poultry houses/ goat farm/ feed godown through bidding to meet the requirement of local stakeholders/eco tourism.

Person of the Month : Mr. Govinda Raju, MLC, progressive farmer and an able leader

The story of Mr. Govinda Raju, MLC, is that of perseverance, ambition and progressive thinking farmer. After finishing B.Com from Bangalore University, he joined Karnataka State Road Transport Corporation (KSRTC) as Traffic Inspector. For 11 years, he was with KSRTC before he quit and took to poultry farming. There has been no looking back. In 1996, he took a plunge into poultry sector, starting Sri Srinivasa Poultry Breeding Farm in Kolar and over the last two decades it has grown phenomenally. The Farm provides employment to over 300 persons directly and over 1,000

As mentioned earlier, he is a thinking farmer, always keen on improving the sector. Being a progressive farmer, he donned the mantle of Vice President of KPFBA from June 27, 2016 to August 5, 2017. He was the Chairman of the Hatching Eggs



Coordination Committee for two terms (August 4, 2015 to August 20, 2019). Keeping his ears to the ground and eyes wide open, he ensured, along with other fellow committee members, that farmers got better rate realization of hatching eggs. Market intelligence was something he was able to grasp easily. n 2020, Mr. Govind Raju became MLC as Janata Dal (Secular) candidate and his mandate was to strengthen Kolar and Chikkaballapur region. A first time MLC, he takes active part in the proceedings, many a times taking up causes dear to our sector.

During lockdown and post lockdown, he was in constant touch with government as to how to overcome the challenges the sector was going through. At present, he is our sole voice in the legislature. His connect in the legislature and government has helped the sector considerably.. Acknowledging his services, KPFBA felicitated him in March 2021 'Abhavandnam Programme'.

Legislator Govindaraju demands government to withdraw order on conversion of land as non-agricultural land

The Janata Dal (Secular) MLC, Mr. Govindaraju has urged the Karnataka Government to withdraw a government order which states that land owners who are engaged in poultry farming in Dakshina Kannada and Udupi districts should convert their land as nonagricultural land.

Mr. Govindaraiu said that the poultry



farmers of these two districts are facing severe problems because of the order which talks about conversion of agricultural land. He added that lands which Are used for poultry farming as non-agriculture land should be repatriated. The Minister for Animal Husbandry, Prabhu Chauhan promised to discuss with the Chief Minister on the inclusion of poultry farms / sector activities under Agriculture sector.

The farmers, he said, were in a dilemma whether the poultry sector belongs to industry or agriculture, even as the Karnataka Land Reforms Act has clearly mentioned poultry farming is considered as agriculture activity. Such government orders in Dakshina Kannada and Udupi districts were the reasons for confusion among poultry farmers.



RECIPE PEPPER CHICKEN DRY

Marinate Chicken with pepper powder; lemon juice and salt. Set it aside for an hour or so.

For Chicken Masala:

Two sliced onions; ginger-garlic paste; one tomato chopped; two green chillies slit; turmeric powder; coriander powder; garam masala; few peppercorns; curry leaves.

Cooking:

Heat oil on medium flame in a wok / pan. Add curry leaves, onions, salt and sauté it until they turn golden brown.

Then add green chillies, ginger-garlic paste and sauté till the raw the smell goes.

After that add spices – turmeric powder, coriander powder, garam masala, crushed pepper, sauté for a minute. Finally add chicken pieces with a very little water. Once cooked and water evaporated, garnish it with curry leaves and crushed pepper. Serve hot.
